

2003 ROLL CALL VOTE DESCRIPTIONS

- 1. Allow 10 Delegates to Require A Bill To Be Considered** - HR 12 would allow 10 delegates to discharge a bill from the committee(s) to which it is assigned to. The committee(s) would have five days to report the bill to the full house. The House would then have five days to take up the issue and vote on it. Many issues, including those dealing with family values, are never taken up by the committee or put on its agenda. Thus the bill dies in committee because of the committee chair's control and opposition.. (HR 12) 2/6/03 RC#34 (71-21).
- 2. Participating in public school courses and activities by child receiving home instruction** (HB 3031) 2/20/03 RC#85 (96-3).
- 3. Requiring informed consent for abortions amendment where the board of medicine evaluates** and investigates complaints rather than following the statute with more extreme penalties. This amendment weakens the penalties showing abortion infractions are less serious. (SB 170) 2/21/03 RC#92 (29-69).
- 4. Amendment to remove the civil remedies provision** (such as compensatory damages) for those not complying with informed consent provision. (SB 170) 2/21/03 RC#93 (23-75).
- 5. Changing the prohibition regarding public disclosure of the female in the abortion.** The judge can already do this. The courts can seal or keep documents from the public by court or individual request. (SB 170) 2/21/03 RC#94 (28-69).
- 6. Passage of the informed consent bill** or Women's Rights to Know Act where the woman is told by telephone or in person by a physician or licensed health care professional at least 24 hours before the abortion is to be performed the medical risks of the abortion, probable gestational age, and the medical risk of carrying the child to term. She has the right to review printed materials, a state sponsored website or information from a physician. (SB 170) 2/21/03 RC#95 (82-15).
- 7. Amendment to Maintain Marriage Fee at \$25** rather than raising it to \$35. Should we be discouraging marriage by taxing it more? (HB 2828) 2/27/03 RC#181 (31-66).
- 8. "Celebrate Freedom Week" instituted during week of Sept. 11** requiring instruction of Declaration of Independence and other founding documents (HB 3115) 2/28/03 RC#303 (89-9).
