

2010 House of Delegates Family Value Voting Records

1. **Marriage Amendment** procedural vote to have the constitutional amendment taken up. (A "Yes" was to lay the amendment over and subsequently have it moved to the inactive calendar thereby killing the amendment in the Rules Committee) (HJR 5) 2/23/10 RC#63 (68-30)
2. **Marriage Amendment discharge motion from Constitutional Revision Committee** Motion to take up HJR 5 to allow the voters to decide if marriage should be defined as only between "one man and one woman". (HJR 5) 2/10/10 (6-19)
3. **Motion to discharge the Marriage Amendment from the Rules Committee** Motion to discharge the Marriage Amendment from Rules Committee where it had been bottled up thereby not allowing an up or down vote on the House floor. (HJR 5) 2/24/10 (5-13)
4. **Ultrasound image option** offered to allow a woman seeking an abortion the opportunity to see the child in her womb prior to having an abortion performed. Abortion providers vehemently oppose this as young girls and women actually see their child the abortionist want to kill. (SB 597) 3/12/10 RC#302 (80-17)
5. **Abortion Amendment** procedural vote to clarify that nothing in this Constitution requires the funding of an abortion. (HJR 10) 2/24/10 RC#66 (64-34)
6. **Healthcare Freedom Amendment** procedural vote to have the constitutional amendment taken up. HJR 103 allows West Virginians, or employers or providers to not be compelled to participate in any healthcare system, e.g. federal imposed plans. (HJR 103) 2/25/10 RC#86 (77-22)
7. **Early parole** for certain non-violent inmates after risk and needs assessment overturning original sentences and its parole status range. The original parole requirement can be waived for an accelerated parole. This early release program is meant to reduce inmate population by several hundred but raises public safety concerns. (SB 218) 3/13/10 RC#426 (82-13)
8. **Authorizing cities, counties (and some school boards) to issue revenue bonds secured by lottery revenues** for public projects. This would increase debt based on "gray machines" revenues and lock in the continuation of gambling to continue debt payments. If the gambling was discontinued and local entities were already liable for a 10, 15, 20, or 30 year bond obligation, the credit rating could be in question and families ultimately would still have to pick-up the tab.
